### Description du cours / Course outline

Ce cours examine la montée en puissance graduelle mais inéluctable de l'ensemble géopolitique mondial qui deviendra l'empire britannique, et qui contribuera au travers des siècles à forger l'identité des nations constituant le Royaume-Uni, tout en renforçant le statut de Londres en tant que centre incontesté d'un pouvoir militaire, économique et politique tendant vers l'hégémonie mondiale. En suivant la trajectoire unique de l'empire britannique à travers les siècles et les continents, ce module offre une vision globale du plus grand et plus efficace système-monde dont l'histoire a été témoin, tout en envisageant ses conséquences dans le monde contemporain.

*This module examines the rise to global relevance of what would become the British Empire, and how this process has contributed over centuries to shaping the identities of the constitutive nations of the United Kingdom, and to fostering the worldwide power of London as a centre of unparalleled military, economic and political hegemony. Following the trajectory of the British Empire across centuries and continents, it delivers a global appraisal of the largest modern imperial world-system history has ever witnessed, and its consequences for the present day.*

### Objectifs pédagogiques du cours / Course objectives

Comprendre et analyser l'histoire moderne et contemporaine de la Grande-Bretagne au-travers de l'impact géostratégique de son expérience coloniale.

*The history of Britain has been shaped by centuries of imperial activity on the five continents. Shaping Global Power helps students understand the modern and contemporary history of the United Kingdom through the geostrategical impact of its colonial experience.*

Berny Sèbe est *senior lecturer* en études coloniales et postcoloniales à l'université de Birmingham (Royaume-Uni). Titulaire d'un doctorat en histoire de l'université d'Oxford, il consacre sa carrière à l'étude comparative des empires coloniaux européens depuis le dix-neuvième siècle, notamment à leur influence sur le monde et les cultures contemporains. Il a publié *Heroic Imperialists in Africa: the Promotion of British and French colonial Heroes (1870-1939)* (2013 et 2015) et codirigé les volumes *Echoes of Empire: Identity, Memory and Colonial Legacies* (2015), *Decolonising Imperial Heroes: Cultural Legacies of the British and French Empires* (2016) et *Decolonising Europe? Popular Responses to the End of Empire* (2020). Il est Fellow de la Royal Historical Society, de la Royal Geographical Society et de la Higher Education Academy du Royaume-Uni.

**Berny Sèbe** is a Senior Lecturer in colonial and postcolonial studies at the University of Birmingham (United Kingdom). He holds a doctorate in Imperial and Commonwealth history from the University of Oxford. His career to date has been dedicated to the comparative study of European colonial empires since the nineteenth century, and in particular their influence on the contemporary world and its cultures. His key publications include Heroic Imperialists in Africa: The Promotion of British and French colonial heroes (1870-1939) (2013 and 2015), Echoes of Empire: Identity, Memory and Colonial Legacies (co-ed., 2015); Decolonising Imperial Heroes: Cultural Legacies of the British and French Empires (co-ed., 2016) and Decolonising Europe? Popular Responses to the End of Empire (co-ed., 2020). He is currently working with Alexander Morrison (New College, Oxford) the volume Empires of Emptiness: Fortresses of the Steppe and the Sahara which examines strategies of colonial control and administration in arid spaces, around the case studies of the Russian conquest of Central Asia and French expansion into the Sahara Desert. Berny Sèbe is a Fellow of the Royal Historical Society, the Royal Geographical Society and of the Higher Education Academy.
